1. Call to Order. Notice that meeting has been filed and posted in accordance with Open Meetings Act

Mr. Dansby called the meeting to order at 1:00 p.m.

2. Announcement of Quorum

A quorum was not present. Members Present: Kimberly Bishop, Traeton Dansby, Brayden Farrell. Members Absent: Kailey Kelpine, Colleen Yoder, Zachary Pearson, Trent Ratterree. The meeting proceeded with presentations only.

3. Recognition of Invited Guests

Mr. Tyrance Billingsley, President, Oklahoma Student Government Association; Mr. Bryce Fair, Associate Vice Chancellor for State Grants and Scholarships, Oklahoma State Regents for Higher Education; and Dr. Chelle' Guttery, Director, Disability Resource Center, University of Oklahoma were in attendance.

4. Minutes of Previous Meetings – Approval of December 3, 2017 Minutes

As no quorum present, the past meeting's minutes were not considered or approved.

5. Update on Oklahoma Student Government Association/Council of Student Presidents Spring Congress and Student Elections –Tyrance Billingsley, President, Oklahoma Student Government Association

The tentative schedule for the OSGA Spring Congress was discussed. Its dates will be February 23rd - 24th, 2018 at Langston University. Traeton Dansby will serve as Floor Leader, Vice-Chair is tentatively set, committee chairs will be Traeton Dansby, Kimberly Bishop, Kailey Kelpine, and Colleen Yoder. The OSGA Board is currently looking for Vice-Chairs and Secretaries for each committee, as well as a Parliamentarian.

6. Oklahoma's Promise and Student Grants and Scholarships – Bryce Fair, Associate Vice Chancellor for State Grants and Scholarships, Oklahoma State Regents for Higher Education

Oklahoma Promise income-limit is now increased to \$55,000 cap with a \$100,000 income cap while the participant is in college. Payment for 0 level courses is no longer possible. All CareerTech programs are now eligible as well. Maximum amount of hours is 129 credit hours. GPA requirement was repealed, now dependent of each school's minimum requirement. Bills which are pending in the House and Senate which will affect Oklahoma's Promise were also discussed.

7. Support for Students with Physical and Mental Disabilities – Dr. Chelle' Guttery, Director, Disability Resource Center, University of Oklahoma

Dr. Guttery discussed disability services, ADA requirements, and trigger warnings. Emphasis on Higher Ed D.S. has a responsibility to level the playing field, but not automatically pass students. Dr. Guttery expressed support for trigger warnings to be placed on the course syllabi, could be beneficial to students with PTSD or other issues.

8. Discussion of Campus Visits

SAB members must talk to at least two campuses to find out what issues exist on their campus - at least two visits are required by law.

9. Determination of Agenda for Next Meeting

Kimberly expressed interest in looking into why prior conviction boxes exist on admission applications. Traeton Dansby expressed interest into meal plan cost analysis on campuses.
