- Chancellor Glen D. Johnson, Oklahoma State Regents for Higher Education and Mr. Jeffrey Harp, Executive Director/Chief of Police, Public Safety, University of Central Oklahoma, and Member of Oklahoma State Regents Campus Safety and Security Task Force
- 4. Recommendations of the Oklahoma State Regents Task Force on the Future of Higher Education in Oklahoma and Discussion of Higher Education Issues Chancellor Glen D. Johnson, Oklahoma State Regents for Higher Education

Chancellor Johnson reminded that the group that the budget cuts have been horrendous for higher education. He explained that classes aren't available when students need to take them, and scholarship rewards have gone down even though research has found that in less than 2 years 67% of jobs will need some college and 37% need at least an associate degree. The Task Force on the Future of Higher Education in Oklahoma are asking the legislature to budget from the allowance of more faculty and too keep the current gun laws the status quo. Chancellor Johnson also spoke about the recommendation he made a year ago to look into the working of our colleges and universities in reference to the changing number of student choosing online options verses on campus options. In order to cut down on costs, institutions have been partnering with each other and having professors teaching at different locations, as well as, having a joint platform between institutions for online classes. It was also explained that there is a

system structure proposal to take place by provided June 30, 2019 hat suggests single governing boards be merged with OSU A&M, OU, and the regional university system board.

 Emergency Procedures and Campus Safety and Security - Mr. Jeffrey Harp, Executive Director/Chief of Police, Public Safety, University of Central Oklahoma, and Member of Oklahoma State Regents Campus Safety and Security Task Force

Mr. Harp spoke about how student safety has become more of a priority due to recent school shooting across the nation and the different ways that the University of Central Oklahoma keeps their students as safe as possible. He explained that people must "must feel safe in order to be safe" so UCO has made sure they have working emergency phones, cameras and mobile alert system. They hold weekly seminars covering what do you do if something were to happen and the ALICE program. Mr. Harp informed the group that a behavioral assessment team is in place to assess the at risk/in crisis people in the community, whether they be a student and or faculty/staff member.
