#### Oklahoma Broadband Office – Samuel Karns

Samuel discussed the reasons the Oklahoma Broadband Office – Grants Office for Digital Opportunities was recently established to provide Oklahomans in rural or underserved communities the opportunity to access internet services.

He explained that just under twenty percent (about 728,000) of Oklahomans do not have access to high-speed internet and many others don't have quality internet. The reasons for lack of internet is largely due to cost and lack of availability of Wi-Fi or devices. Other barriers include the lack of knowledge for using the devices or feeling they don't need the internet. Goal is to have high-speed internet available to all Oklahomans by 2028.

Various types of grants are available. Samuel is asking for our help to create proposals for where the money should be spent. The federal government hopes to see the state governments establish their own digital equity plans, so if we wish to make our own he asks that ours be submitted to him to ensure that they align with the other plans in Oklahoma.

For those that wish to attend the Digital Equity Coalition meets every other month & their next meeting is October 17, 2023.

#### RSU

- All staff received at least a 5% raise this fiscal year, and minimum salary across campus has been raised to \$30k.
- Opening for First Year Experience & Instruction Librarian New and established librarians encouraged to apply if you know anyone!
- Library project being highlighted during <u>RSU's Giving Week</u> Native American Music Digitization & Preservation Initiative. (Feel free to share if you know anyone who would be interested in supporting this project!)
- We have been informed that we should to be getting 20 new computers in the library to replace severely outdated tech that has been giving students issues for over a year now.

#### Oklahoma City University

We are hiring for 2 positions: <u>Music and Performing Arts Librarian</u> and <u>Circulation Technician (Sunday-Thursday 3 pm - 12 am</u>). We did eliminate one position, but reorganized duties and everyone got a raise.

#### **Connors State College**

Mr. Chris McBeath was appointed VPAA for Connors State, and for the first time in many years a feeling of hope prevails on the campus

The library purchased and added 9 Hotspots to our equipment checkout. They are very popular

The library personnel got permission to conduct a day-long retreat that was very productive. We have a slate of activities for the fall and spring mapped out based on the retreat

A building renovation forced several classes to move to library spaces in Warner. We have enjoyed having more students in the library, who stay to study

#### Rose State College

- Dr. Christie Smith, Dean of the Learning Resources Center and Library, vacated her position in June to go back to Mid-America Christian University. Her position will not be filled.
- The library director is now overseeing the duties for our Academic Testing Center and our Tutoring Center within the same building.
- For FY24, professional library staff received a \$2,000 raise. Classified library staff received a \$3,000 raise.
- Through our Friends of the Library funds, the library was able to purchase two Microsoft Surfaces and stands for students to make study rooms reservations.

#### **Redlands Community College**

- Jena Marr was appointed President of Redlands Community College on August 28, 2023
- The library began loaning laptops in August 2023

#### OSU-Tulsa Library

Is an organizing partner for a community read entitled Deep Greenwood. Events follow sets of chapters from Victor Luckerson's best seller "Built from the Fire."

Across a series of five events over the next year, *Deep Greenwood* will examine the 118-year history of Greenwood step by step, with each event capturing a different era. The series will begin by exploring the racist politics in Tulsa that preceded the massacre, and end with an opportunity to imagine new possibilities for Greenwood's future. In between attendees will learn more about Greenwood's vibrant culture and nightlife, the impacts of urban renewal, and the legacy of activism in the neighborhood. #### **OSU Center for Health Sciences**

Our satellite campus OSU College of Osteopathic Medicine at the Cherokee Nation (OSUCOM-CN) will graduate its first class of 54 medical students in May 2024. They started in August 2020 during the height of the COVID-19 pandemic.

Two new librarians will start in December on the Cherokee Nation campus.

Our longtime Library Technical Assistant for Cataloging is retiring in December.

- Absent Governor's action, appropriations increase for SFY 24 of \$500,000 became law. Budget request was \$825,945. Total increase of 11.02% from \$4,536,315 to \$5,036,315. Highest figure since 2016.
- Absent Governor's action, \$17,605,000 from the new Legacy Capital Financing Fund for renovations to the Allen Wright Memorial Library became law as of today. Conversations have started with OMES on renovation planning.

#### Affecting ODL

- <u>HB2557</u>, McBride: Authorizes the Dept. of Libraries to utilize up to \$27 million in appropriated funds for relocation, remodeling and construction projects at buildings they control including The State Library.
  - Failed deadline.
- HB1004x, Wallace and Thompson: General Appropriations bill. ODL received \$500,000 in increased appropriations.
  - Became law absent Governor's action.
- HB1014x, Wallace and Thompson: Appropriates \$17,605,000 from the new Legacy Capital Financing Fund for renovations to the Allen Wright Memorial Library.
  - Became law absent Governor's action.

#### Shell Bills – all failed the deadline

- HB1128, Speaker McCall: Creates the Oklahoma Public Libraries Reform Act of 2023.
- <u>HB1129</u>, Speaker McCall: Creates the Oklahoma Public Libraries Reform Act of 2023.
- HB1817, Rep. Conley: Creates the Oklahoma Libraries Act.
- HB1818, Rep. Conley: Creates the Oklahoma Libraries Act of 2023.
- <u>HB1819</u>, Rep. Conley: Creates the State Libraries Act of 2023.
- <u>HB2568</u>, McBride: Creates the Oklahoma Department of Libraries Act of 2023.

#### Library Administration and Operations

- <u>SB5</u>, by Sen. Kevin Matthews, D-Tulsa and Rep. Monroe Nichols, D-Tulsa. Request bill from TCCL. Amending 65 OS 2021 Section 155, which relates to city-county library commissions; modifies language related to city-county library commissions. It reduces the number of times the commissions must meet from at least one meeting each month to no fewer than six times per year.; providing an effective date; and declaring an emergency.
  - Failed deadline.
- <u>SB261</u>, Howard: Request from Oklahoma Library Association. Defines Public Libraries as political subdivisions under the Governmental Tort Claims Act.
  - o Failed deadline.
- <u>SB521</u>, Pugh: Request from the State Regents for Higher Education. Exempts libraries within institutions of higher education from filtering out certain digital or online database resources when the primary purpose of the resource is for educational research. (<u>HB3702</u>)

- Failed deadline, but language was added to <u>SB 322</u>, which became law absent governor's signature.
- <u>HB2618</u>, Humphrey: Permits counties that participate in multi-county library systems to vote on adoption of procedures relating to overall budgets, estimates of needs, and purchase approvals.
  - o Failed deadline.

#### Related to Obscenity, Parents Rights, Restricting Access to Materials Based on Content

- <u>HB1810</u>, Conley: Prohibits certain materials from school libraries, requires parents involvement in determining whether materials are sensitive, compels the State Board of Education to provide implementation guidance.
  - Failed deadline.
- <u>HB1811</u>, Conley: Prohibits certain materials from school libraries and requires a written policy for challenging school materials.
  - Failed deadline.
- <u>HB2002</u>, Conley: Establishes standards in statute of obscene material harmful to minors and adjusts the definition of obscene material to include written and drawn mediums.
  - Failed deadline.
- <u>HB2186</u>, West: Prohibits adult cabaret and drag queen story hours anywhere in proximity to children, violators to be guilty of a misdemeanor.
  - o Failed deadline.
- <u>HB2535</u>, by Rep. Danny Williams, R-Seminole and Sen. Blake Stephens, R-Tahlequah, modifies the definition of the term "obscene," removing "average person applying contemporary community standards" and replacing it with "a reasonable person." It exempts from the reasonable person standard when an adult knowingly provides material that qualifies as obscene material.
  - o Failed deadline.
- <u>SB95, Standridge:</u> "No public school district, public charter school, or public school district or public charter school employee may provide any sexually explicit material including but not limited to any book or other written medium containing sexually explicit material to a student enrolled in the public school district or public charter school without written consent from the student's parent or legal guardian."
  - Failed deadline.
- <u>SB397</u>, Hamilton: Original version required public and school libraries to conduct inventories and designate all materials with one of the following ratings: elementary, junior high, under 16, and juniors and seniors. "Beginning July 1, 2024, public libraries shall place print and nonprint materials and media designated as "juniors and seniors" in a section of the library only available to staff." Individuals under the age of 18 can only access if they present a written consent from a parent or legal guardian.
  - A substitute was introduced that removed this language and instead instructed the Oklahoma Department of Libraries to create procedures to be approved by the Legislature and adopted by school districts for the review and acquisition of collection materials.
  - Failed deadline.

- <u>SB503</u>, Bullard: Prohibits political subdivisions from allowing or permitting a public display of lewd acts or obscene material where minors could be present, intentional violators to be guilty of a felony.
  - Failed deadline.
- <u>SB872</u>, Bullard: Forbids school libraries from containing certain materials, requires an annual audit of materials and public database of available materials, and outlines procedures for removing books.
  - o Failed deadline.
- <u>SB935</u>. Jett: Creates the Stop the Wrongs to Our Kids and Employees (Stop W.O.K.E.) Act prohibiting the teaching of or inclusion of teaching materials that promote critical race theory.
  - Failed deadline.
- <u>SB988</u>: Sen. Jett: Prohibits the targeting of minors with content or messages containing obscene material or sexual conduct under the Consumer Protection Act.
  - o Failed deadline.
- <u>SB1017</u>, Jett: Prohibits school surveys from including coverage of gender or sexuality and limits school library materials from including any materials on LGBT topics or recreational sexualization.
  - Failed deadline.
- <u>SB1056</u>, Sen. Standridge: Defines standards and conditions for obscene content. Permits community polls and news outlets as reference. DA doesn't want this to be heard either.
  - o Failed deadline.

#### **General Interest**

- <u>SB139</u>, <u>Dahm</u>: Adds required reading to certain high school classes: Bill of Rights, the Anti-Federalist Papers, the Articles of Confederation, the Gettysburg Address, George Washington's Farewell Address, the 1777 version of the New England Primer, and The Law by Frederic Bastiat.
  - Failed deadline.
- <u>SB119, Bergstrom</u>: Right-to-Start Act. Creates the Office of Entrepreneurship in the Department of Commerce. "The Office shall work with stakeholders and organizations supporting entrepreneurship to enhance learning and skills, provide technical support, and expand access to resources for entrepreneurs across this state."
  - o Failed deadline.
- <u>HB2420</u>, Alonso-Sandoval. State Department of Education to develop best practices and recommendations for instruction in digital citizenship, internet safety, and media literacy. Involve librarians.
  - Failed deadline.
- <u>SB509</u>, Matthews. Authorizes Oklahoma Historical Society to create the Oklahoma Civil Rights Trail Grant Program.
  - o Became law absent Governor's action.
- <u>SB 621 by Sen. Pugh, Rep. Hill, Rep. Archer, and Rep. Lepak.</u> Creates the Oklahoma Workforce Commission. Gives them the authority to create a nonprofit that manages the state's WIOA funds. This entity will set and coordinate the state's agenda for workforce development.
  - Signed by Governor.

- <u>HB1568</u>, by Rep. Marilyn Stark, R-Bethany and Sen. Dave Rader, R-Tulsa, creates a sales tax exemption for sales of tangible personal property or services to a nonprofit organization, created pursuant to the provisions of Oklahoma law or authorized to conduct activity in Oklahoma pursuant to the nonprofit entity law of another state, having exempt status pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, in good standing and having gross revenues not to exceed \$3.0 million during the tax year ending on the date immediately preceding the first date after the end of such tax year upon which the entity seeks to make otherwise taxable purchases of tangible personal property or services. It exempts purchases of alcohol or tobacco by the nonprofit entity.
  - o Failed deadline.

# Digital Equity Act




- Passed in 2021 as part of the Infrastructure Investment and Jobs Act to ensure that Oklahomans can access, afford, and use the internet
- OBO will receive funds from the Digital Equity Capacity Grant Program to support digital inclusion opportunities in the state
- >OBO is drafting a Digital Opportunity Plan
  - Will be published for public comment before being submitted to NTIA

- Create database of community anchor institutions and digital equity services






