    - Have to consider where money would be stored. There's no centralized account with OSRHE
- 2. Amy Cowley Business and coop program rural development department
- a. Universities can be eligible for grants
  - Rural utility service
    - Distance Learning and Telemedicine grant
    - Definition of Rural is <50,000 in population
    - Three programs

#### 1) Rural cooperative program

- Cooperative development centers
  - Funds can be used for Operation
- IHE are eligible applicants
- 25% match (Land grant/tribal schools only have a 5% match)
  - Funds can be used for Feasibility studies, Business plans, Strategic planning

- 60 day application window, open during the summer, closes on June 26<sup>th</sup> this year
  - •

#### 2) Rural business development grant

- Closed opens again in fy24
- Small and emerging businesses in rural areas
  - <50 employees
  - <50,000 population
  - <\$1 Million income
- Public universities, Tribes, Municipalities are eligible applicants
- Match is not required, but will give a higher score.
- Equipment/real estate/training
  - Buy equipment and lease for the useful life

- Business plan assistance
- Strategic plan for small business
- Training for small business
  - Recent award was used to create small business bootcamp Durant, OK
- Create small business incubators
- A tribe did a co-working space
  - Like an incubator, but allows people to rent desk space and internet connection
- Commercial kitchen in Lavern, OK
  - Lease space to local sauce makers
- Aquaponics project with Eastern and tribes
  - Trained entrepreneurs who want to own their own aquaponic system and helped them get started
- Tandy asked question. How to come up with feasible data of creating jobs
  - Answer These grants are jobs-driven and want to know directimpact: direct jobs that will be saved/created
    - Facility manager
    - Example of direct impact: "We will do this for 12 months and will have 4 workshops and have 20 people there"
- Susan Trombley asks if they have an EDA, could they use USDA grant to purchase equipment and expand training for students with support letters from businesses stating they need that training. Can it be different phases
  - Answer: Other funds have to be confirmed
    - Whole project has to be viable and can't be partially funded
    - Different phases of projects are okay.

#### 3) Rural Innovation Stronger Economy (RISE)

- A larger incubator Innovation center
  - Lead applicant (IHE) needs a Formal partnership (like city)
  - Ada built new firestation
    - Grant funds are being used to convert old one to an innovation center. Project will be done in phases (first floor for now).
- Innovation center to provide training for high-wage jobs in industry in area.
  - Can pay for operation and construction of operating center
- Not leased to businesses, it's own entity.
- Requirements:
  - 20% match of total project
  - Has to be actual formal partnership
- Show who's receiving the training
  - What businesses will receive benefit
- Currently closed more funding expected
  - 11 Federal awards (OK received 1)
- Can submit plan and scope to receive feedback from committee. Like an abstract project narrative/scope.
- Communities are eligible on a percentage basis based on population
- (<u>https://www.rd.usda.gov/</u>) -> scroll to bottom -> signup for updates -> select interest areas

  - The question was asked about grant management software
    - UCO uses Cayuse for pre-award (<u>https://cayuse.com/</u>)
    - UCO uses Info-ready for internal documents (<u>https://www.inforeadycorp.com/</u>)
      - Have to submit external projects through this.
    - UCO uses IRB manager for all compliance
    - Kuali was also mentioned as an option for grants management (<u>https://www.kuali.co/</u>)
  - Jamie mentioned gardening software could help with grant tracking
  - GPA website may have resources on grant management software
