1. Welcome and Introduction of Members and Guests: Cass Minx

2. OSRHE budget update/overview: Sheri Mauck

FY26 Budget Overview

Budgets have been approved and FY26 officially began, with allocations starting in May.

- Total increase in operations funding: \$23.9 million.
 - The majority earmarked for specific legislative initiatives.

Earmarked Funding Breakdown

- \$3 million: Intensive math tutoring program at the University of Oklahoma.
- \$20 million: Prosperity funding for rural communities.
 - \$10 million: UCO Forensic Science Program.
 - \$10 million: Cameron University STEM education and cybersecurity.

Academic Scholars Program

- \$2 million: Initial increase for the new "Rising Scholars" initiative.
- Funding does not fully meet the program's needs but is a starting point.

Debt Service Adjustment

- Reduction in debt service appropriation due to savings.
- Legislature reduced OSRHE's appropriation for the 2005 bond issue (debt service continues through 2034).

Deferred Maintenance Funding

- No new operational funding, but no cuts either—considered a win.
- Accelerated release of deferred maintenance funds:
 - Originally set for 4 years, now institutions will receive the next 3 years' worth in FY26.
 - OU and OSU excluded from this funding.
 - Funds not yet received; pending release by the Oklahoma Capital Improvement Authority (expected September).
 - Institutions have been informed of their allocations.

Critical Occupations in STEM Funding

- Original \$11.5 million set aside 3 years ago for STEM-related critical occupations.
- Reallocated in FY26 using a new methodology:

- Defined list of STEM programs developed with CASS and the data group.
- 50% of funds allocated based on average graduates from FY22–FY24.
- Also considered credit hour production to support workforce development.
- Resulted in some shifts in institutional funding.

3. Economic Impact Study: Cass Minx

Study Focus Areas

- Educational attainment trends in Oklahoma, Enrollment and degree conferral trends, Economic and fiscal impact of public colleges and universities, Employment outcomes of graduates.
- New sections:
 - Oklahoma's Promise impact.
 - Community benefits from student, faculty, and staff engagement (e.g., volunteering, internships).

Key Findings

- Educational Attainment:
 - Increase from 31% (2014) to 36.1% (2023) of Oklahomans (25+) with an associate degree or higher.
- Median Annual Earnings:
 - Increased across all education levels (based on U.S. Census data).
 - Higher education continues to correlate with higher earnings.
- Inflation-Adjusted Income:
 - Despite earnings growth, real income decreased by ~1.1% annually after inflation adjustment.
- State System Expenditures:
 - Raw numbers increased, but 0.7% decrease after adjusting for inflation.
- State Appropriations:
 - 3.5% decrease year-over-year after inflation adjustment.
 - Some recent increases (2022–2024), though often one-time funds.
- Institutional Employment:
 - 11.4% decrease in full-time equivalent employment over 10 years.
 - Largest drop from 2021–2022, likely due to the "Great Resignation" and COVID-19 disruptions.
- Wages & Benefits:
 - Held steady with a 0.4% decrease after inflation adjustment.
- Oklahoma's Promise:
 - Decline in enrollment, but degree completion remains stable.
 - 2.4% decrease in funding after inflation adjustment.

Economic Impact (FY2024)

- Total Economic Output: \$14.61 billion.
- Employment Impact: Over 111,000 jobs.
- Wage Impact: \$7.07 billion.
- Tax Revenue Generated: \$461.82 million (sales + income tax).

- Return on Investment:
 - \$17.48 in economic output for every \$1 in state appropriations (up from \$9 in 2019).

Community Engagement Impact

- 53,000+ students participated in experiential/service learning, internships, and clinicals.
- 3.78 million hours contributed statewide.
- Economic value of volunteer hours: \$10.88 million.
- Faculty and staff also contributed significantly.

4. Economic Development Council Orientation: Lucia Dickinson

Council Overview

- The Economic Development Council (EDC) was established in 2006 by directive of the President's Council.
- Purpose: To maintain ongoing dialogue among economic development professionals across Oklahoma's public higher education institutions.

Membership & Structure

- Current Membership: 28 members (recently added Pocket City University Center).
- Members are chief economic development professionals selected by institutional presidents.
- Meeting Frequency: Every other month.
- Executive Committee:
 - Chair: Whitney Alves
 - Includes equal representation from 2-year and 4-year institutions.
 - Responsibilities: Assist with meetings, planning, and event execution.

Mission & Goals

- Mission: Create a high-quality environment to:
 - Retain college graduates.
 - Attract and grow businesses in Oklahoma.
 - Develop new businesses through efficient resource use.
- Key Focus Areas:
 - External Partnerships: Foster collaboration between institutions, businesses, and government entities.
 - Workforce Development: Align academic programs with industry needs.
 - Data Collaboration:
 - Work with Lightcast representatives for labor market data and partnership insights.

• Collaborate with Career Services Council to review post-secondary employment data and support statewide workforce development.

RBPEA (Regents Business Partnerships Awards)

- Annual award recognizing impactful institutional partnerships.
- Institutions contribute \$500, matched by OSRHE.
- Encouraged to select partnerships early and document progress.
- Potential changes to the RBPEA format are under discussion.

6. Legislative Update: Joel Dean

Legislation Overview

- Approximately half of the higher education-related bills passed during the last session went into effect on July 1, 2025.
- The remaining bills, including those without emergency clauses, will go into effect on November 1, 2025.
- Topics include:
 - Scholarship funding changes.
 - Insurance rate adjustments.
 - Other high-level administrative policies.

Clarification on Specific Legislation

- Questions have arisen regarding the maternal leave bill.
 - Although passed, it will not be effective until November 1, 2025.
- Institutions or individuals with questions about specific legislation or implementation guidance should contact Joel Dean directly for clarification or documentation.

Looking Ahead: Legislative Planning

• Preparations are underway for legislative tours and engagement with new legislators following upcoming elections.

• The format and approach for these events may change, with more details to come.

7. Upcoming Interim Studies: Joel Dean

Interim Studies

- Senate interim studies have been approved.
- House interim studies are still under review, with over 120 requests submitted.
 - Final approval expected by July 30, 2025.
- Interim studies are used to explore potential or past legislation with expert input.

Confirmed Interim Study

- OSRHE is collaborating with Senator Hicks on a Senate interim study focused on:
 - Protecting student access and accountability.
 - Closing transcript release loopholes at for-profit colleges.
 - Study expected to take place in September or October (dates TBD).

Other Proposed House Interim Studies (Pending Approval)

- Topics include:
 - CareerTech and high school grade classification.
 - Concurrent enrollment.
 - Teacher recruitment and retention.
 - Business innovation and workforce development.
 - Return on investment of post-secondary education.

Next Steps

- Joel will distribute a finalized list of approved interim studies once available.
- Calendar invites and updates will be shared for any studies involving OSRHE.
- Council members may be contacted to contribute expertise to relevant studies.
